Comprehensive quality planning is another component of the zero-defect-objective and helps to avoid potential errors before they occur.

Our actions conform to the following principles:

The prevention of environmental pollution, energy waste, accidents and illnesses, as well as the consideration of climate change and its effects, is a high priority in all processes.

As a company, we are integrated into our social and natural environment and are therefore dependent on its performance. Compliance with applicable laws and other requirements relating to environmental impact, energy use, energy consumption and energy efficiency is a matter of course for us.

In addition to complying with legal requirements and regulations, we are committed to the continuous and systematic improvement of our company's environmental and energy performance.

We consider the entire life cycle of all industrial activities and our products. This means minimizing the consumption of energy, water and other resources, reducing the generation of waste, emissions and by-products and supporting waste management so that waste products become recyclable materials.

Together with our development partners, we endeavour to focus on the most energy-efficient processes possible, particularly in the case of new developments. In addition, we aim to take climate-relevant effects into account as early as the planning phase and implement suitable adaptation measures. Depending on availability, we favour regional suppliers with comparable performance. The aspect of energy efficiency is taken into account when procuring new systems.

For this reason, every employee is integrated through training as part of the development of the environmental and energy management system and included in the company's environmental protection measures.

Environmental and energy aspects are taken into account through forward-looking planning and action within our operational value chain, from the receipt of raw materials to the finished product ready for despatch.

Emergency plans are used to ensure a secure operating status in the event of disruptions in order to fulfil existing requirements and ensure the ability to deliver the contractual products.

Sustainability

Sustainability is firmly anchored in the corporate strategy and culture at BECHEM. As a family-owned company, we are convinced that acting responsibly in terms of Corporate Social Responsibility (CSR) is a prerequisite for the sustainable economic success and future viability of our company.

Renewable energy from our photovoltaic plants supplies the production and the administration at the headquarters in Hagen and at our plant in Gardelegen-Mieste. The three BECHEM locations in Germany are exclusively supplied with green electricity since 01.01.2023. Thus, we cover - in addition to the self-generated electricity by photovoltaic plants - the entire electricity demand by renewable energies, implement defined targets of our sustainability strategy and reduce our CO₂ footprint.

We are at home in the chemical industry and therefore feel an even greater obligation to reconcile business and the environment with sustainable concepts. The fundamental attitude of the company management as well as the workforce towards topics such as climate protection, resource conservation or even conscious nutrition are also of decisive importance for our sustainable actions.

We develop sustainable products, all of which have always made their contribution to sustainability, because they have always been developed to reduce friction and wear, increase service life and minimize maintenance. We also think „green“ in our product developments, selecting raw materials that conserve resources and avoiding raw materials that pollute the environment.

In addition to recyclable containers for our lubricants and ecologically degradable lubricating greases, we are continuing to develop our energy-efficient and resource-conserving production processes. This is done within the framework of sustainability management, which covers environmental aspects and social aspects such as human rights, no child labor, equal treatment, discrimination with regard to origin and religion.

Another important component of sustainability management is the recording of greenhouse gas emissions and the coordination of reduction measures.

We are committed to continuous and systematic improvement of the sustainability of our company beyond compliance with legal requirements and regulations.

Security

It is our effort to recognize and to minimize any risks with preventive measures already at the beginning of our planning and processes.

The company management will provide all necessary resources for the implementation, the safety of our facilities is maintained by periodic and continual maintenance all the time.

All business and work processes and interfaces within our company are captured by a security system.

The prerequisites for continual improvement and advancement of our security management system is to set goals and to do periodic analysis and valuation of our safety standards.

The periodic provision of audits and inspections locally ensure the effectiveness of our security management system.

An essential component for further development is a continuous improvement at all levels. The effectiveness of strategic and operative measures are recognizable in performance indicators for a continuous improvement.

The effectiveness of our management systems is going to be monitored with internal and external audit measures about an annual planning.
